1. Only signs acquired at City Hall are permitted – NOTE: Signs CANNOT be altered in any way – NO BALLOONS
2. No sign can be placed within 200 feet of Georgia Highways 54 or 74.
3. Signs may be placed one day prior to the sale after 5:00 p.m.
4. Signs must be removed immediately after the sale.
5. No sign can be placed in a median.
6. No sign can be affixed to a utility pole, tree, or existing sign.
7. No sign can be placed more than 36 inches (3 feet) feet above the ground.
8. Signs placed in public right-of-way must be at least 5 feet from the curb, and no more than 10 feet from the curb, and must be within 50 feet of an intersection.
9. All illegal signs will be removed.
10. Limit Yard/Garage/Estate/etc. sales to twice per year per residential address.

RULES AND REGULATIONS FOR BLANK SIGNS

1. Non-Commercial Speech ONLY (meaning No sales of any type)
2. Must abide by all rules above regarding appearance and placement
3. Any variation requires permit from Planning Department
